Your data will also be shared with HMRC and your bank as required for administering your donation. Under the General Data Protection Regulations your data is held under the categories of legitimate interest and legal requirement. The law gives you rights relating to your data including the right to see your data and have any mistakes corrected. If you have concerns over how GCB is using your data, you can lodge a complaint with the Information Commissioner's Office, although we encourage you to speak to us first.
